- I have received instruction on the use of the equipment and fully understand its use and function.
- I have made no misrepresentation to the ski shop concerning my height, weight, age, or skier type.
- I verify that the visual indication settings recorded on this form agree with the numbers appearing in the visual indicator windows of the equipment listed on this form.
- I agree to hold harmless and indemnify the ski shop and its owners, agents, and employees, as well as the equipment manufacturers and distributors for any loss or damage, including any that results from claims for personal injury, death, or property damage related to the use of this equipment.
- I understand that there are inherent and other risks involved in the sport of snow skiing, and snow boarding, for which this equipment is to be used, that injuries are a common and ordinary occurrence of the sport, and I freely and voluntarily assume those risks.
- I understand that a ski-binding-boot system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release, and it is therefore, no guarantee of my safety.
- I hereby release from any legal liability the ski shop and its owners, agents, and employees, as well as the manufacturers and distributors of this equipment from any and all liability for damage and injury or death to myself or to any person or property resulting from the selection, installation, maintenance, adjustment or use of this equipment and for any claim based upon negligence, breach of warranty, contract or other legal theory, accepting myself the full responsibility for any and all such damage, injury or death which may result.
